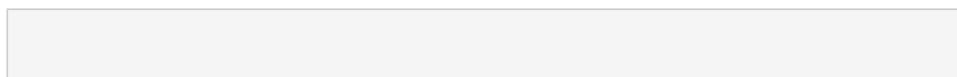

These explorations contribute to the debates surrounding the fragmentation of international law arising from its expansion and diversification.
